- The unapproved landscape (rocks) for units 333/329/325 is still under discussion as to what will be done for the improvement of the property and the removal of the rocks. -approved for rocks to be removed & pavers to be put in place. We are going to wait to address this issue.
- Purchasing rocks/boulders for the lawn to prevent people from driving on the lawn- still working on determining if needed. - we will readdress this concern in the fall of 2020
- The landscaper said that there are 4 trees that need to be removed may wait until fall to replace trees- we will wait until the fall to replace these trees.
- Edging replaced- still waiting to hear back from landscaper as to what the best solution on this will be

Building Maintenance: / Hardscape Maintenance:

The following projects are items that need to be worked into the schedule and budget.

- 1) Wood trim painted on 1617 & 1630 getting bid
- 2) Get pricing for painting the brown stucco on the outside of all units. Getting bid
- 3) 1653 said we haven't fixed the ceiling where it leaked. we will check with them again to see what still needs to be fixed.
- 4) 1653 rain gutter in front of building will be checked
- 5) Resurface the Road Review bid that we have received wiil schedule road to be resurfaced in July 2020
- 6) Bountiful City Electrical box- need to call the city and have them replace the cement block.
- 7) Pump in a swamp area and protecting 1653 from flooding when the swamp backs up. -solutions that were discussed are to rewire GFI outlet to a new location get a second pump in the hole. Window well installed on the west window of 1653 to protect them from potential flooding.
